I acknowledge that TWELFTH PRECINCT PISTOL AND ARCHERY CLUB INC. is a private club established in 1936 to promote the safe handling, care and use of firearms and archery equipment for the purpose of improving marksmanship and providing a safe environment for the practice of archery and shooting sports.

I further acknowledge that shooting sports have inherent risks, hazards and dangers that cannot be eliminated particularly in a wilderness and shooting environment, including, but not limited to:

1. The risk of handling firearms and archery equipment and being near others that have firearms or such archery equipment in their possession.
2. The risk of injury from ammunition or arrows shot from other bows or guns.
3. Walking in rugged country, including encounters with wildlife, animals and insects.
4. Inclement weather conditions
5. Failure to use proper safety equipment as required by the club.

I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning, degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

Lastly, I, for myself, my heirs, successors, and executors, hereby KNOWINGLY AND INTENTIONALLY INDEMNIFY THE TWELFTH PRECINCT PISTOL AND ARCHERY CLUB, INC. their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of the services, animals or equipment, whether such damage, loss, injury, paralysis or death results from negligence of TWELFTH PRECINCT PISTOL AND ARCHERY CLUB INC. or from some other cause INCLUDING BUT WITHOUT LIMITATION, contracting the COVID-19 virus or other such malady.
